Guide To COVID-19 Community Mitigation/Protective Measures

In order to keep our community safe and prevent the spread of COVID-19, the Saint Paul City Council passed an emergency ordinance that outlines community mitigation/protective measures. Listed below are a summary of these mitigation/protective measures.



Pre-Travel Testing

All individuals, regardless of age, traveling to Saint Paul Island must submit a negative COVID-19 test result to the City within 48 hours prior to travel. If using an over-the-counter (OTC) home test for pre travel testing, please test and send results 24 hours prior to travel.



5-Day Post Travel Quarantine

All individuals, regardless of vaccination status, are required to quarantine for five (5) days upon arrival; however, individuals may go to the store, post office and other businesses for essential services wearing recommended masks (*see Use of Anġiliisiġ below*) while in these locations. Individuals shall also follow Post-Travel Testing requirements (*below*).

Individuals residing within the same household shall quarantine for five (5) days upon arrival of the traveling individual and are subject to the same post-travel testing, regardless of vaccination status.



Post-Travel Testing

All individuals, regardless of age and vaccination status, must submit a negative COVID-19 test result to the City within 24 hours after arrival on Saint Paul Island and then again on day five to be released from the 5-day quarantine.

Reminder that the City does accept over-the-counter and home antigen tests. Send a picture of your results to snpcovid19@stpaulak.com.



Use of Anġiliisiġ (breath catchers/face masks/face coverings)

Anġiliisiġ are required at the following locations:

- Saint Paul Health Center
- Aleut Community Store
- City Hall for public/visitors
- Saint Paul Post Office
- Saint Paul Airport Facility

Wearing an anġiliisiġ, double masking, KN95 or N95 masks in all public indoor settings is recommended. Cloth masks are not recommended.



Community/Workforce Protection Plans

Community/Workforce Protection Plans are required for critical infrastructure and essential workers. These are required to be submitted to, or have on file at the City and approved prior to travel. If your agency or business has not submitted a Community/Workforce Protection Plan, please email snpcovid19@stpaulak.com or fax to 1-866-570-9745.



Daily Testing Critical Infrastructure and Essential Workers

Essential and critical infrastructure workers who will be in contact with residents and/or other essential and critical infrastructure workers that are not able to isolate in their workplace within the five (5) day quarantine period, may work under a Community/Workforce Protection Plan. These individuals shall be subject to daily continuous screening testing using an antigen-based test for five (5) days after arrival on Saint Paul Island. Daily test results must be reported to the City.



COVID-19 Testing

COVID-19 testing is readily available on Saint Paul Island. Free COVID-19 tests kits are available from the City for traveling residents and essential workers that are testing daily. To request a home test kit, email snpcovid19@stpaulak.com or call 907-546-3130.

The City offers drive-up testing by appointment.

Testing schedule:

Mon-Fri: 8 am–5 pm Sat-Sun: 1 pm–4 pm
